**A RESOLUTION APPROVING THE APPROPRIATION ORDINANCE NO. 52-S-2018 OF THE SANGGUNIANG BAYAN OF BONIFACIO, “AN ORDINANCE APPROPRIATING THE TOTAL AMOUNT OF FIFTEEN THOUSAND PESOS (PHP15,000.00) THRU RE-ALIGNING THE LCPC APPROPRIATION 2018 PARTICULARLY THE COMPREHENSIVE LOCAL JUVENILE INTERVENTION PROGRAM (CLJIP) PLAN FORMULATION TO BE UTILIZED AS PAYMENT OF THE MEALS AND SNACKS OF THE LAND BANK PERSONNEL WITH DSWD, MSWD AND LGU PERSONNEL DURING THE TWO-DAY PAY-OUT FOR THE BENEFICIARIES OF THE UNCONDITIONAL CASH TRANSFER (UCT) UNDER THE LISTAHANAN PROGRAM OF THE DSWD”**
